The Controlled Environment Building Association (CEBA) has made updates to their governance that will better position them **to provide additional valuable member programs and grow their presence globally.** CEBA will continue to have a strong relationship with both GCCA and GCCF and be a key partner in joint initiatives. These include advocating on behalf of the industry, educating and training future leaders and developing valuable tools and resources for the collective memberships.

While 2022 was a great year, I am extremely excited about what has yet to come in 2023 and beyond. The associations have never been stronger, and we are in a fantastic position to continue to grow the organization and the value proposition that we serve to our members in 2023 and beyond. **Here's to another great year!**

# INTERNATIONAL ADVOCACY

GCCA Canada has partnered with the government affairs firm TACTIX to assist the association with its advocacy efforts in country. In addition, GCCA Brazil continues to advocate on behalf of the industry in Brazil with a government affairs consultant based in the country's capital, Brasilia, to improve advocacy efforts for

regional members. Both experts assist members with a variety of regulations, succeed on intervening on numerous issues impacting the industry and have been working to find ways to ensure the cold chain has a seat at the table.

Priorities: GCCA conducted advocacy priority surveys in Canada, Europe/UK and the United States to identify the key focal areas for GCCA advocacy programs in those regions. The top priorities identified were: Labor, Food Safety, Occupational Safety, Energy, and Sustainability/Refrigerants.

# OCACY EFFORTS



#### **WHITE HOUSE**

In 2022, GCCA met with the White House on numerous occasions to discuss key policy issues impacting the cold chain. GCCA has leveraged these relationships to highlight key issues such as supply chain disruptions, rail and port labor, food security and nutrition. GCCA continues to work with the Administration to help address the challenges our industry faces.



#### FDA

GCCA met with senior agency leaders, including Commissioner Califf, on multiple occasions to advance GCCA priorities on FDA regulations, enforcement policies and overall operations of the agency's food programs.



#### USDA

GCCA led a coalition of industry partners and the Port of Houston to secure USDA funding to build a refrigerated chassis pool at the port to facilitate growing export demand.



#### **CONGRESS**

GCCA is actively engaging with Congress to address the challenges facing our industry by briefing the House and Senate Agriculture committees on a regular basis. GCCA successfully worked with Congress and coalition partners to secure passage of important legislation including the Ocean Shipping Reform Act and the Food Donation Improvement Act. GCCA and coalition partners were also successful in expressing opposition to concerning legislative proposals such as the PRO act.









#### **REGULATIONS**

In 2022, GCCA continued its ongoing efforts to address regulatory issues impacting the cold chain. GCCA provided comments and testimony to federal agencies including USDA, FDA, EPA and OSHA covering a wide range of regulatory programs and policies.



#### **COALITIONS**

GCCA actively participated in over 20 coalitions during 2022. Through these coalition efforts, GCCA met with key policy makers across Congress and the Administration as well as signed multiple letters advocating on policies including pandemic relief, taxes, supply chain, labor, trade, transportation and the environment.



### LEGAL

Enabled by Advocacy Fund resources, GCCA helped lead a successful amicus brief on OSHA litigation that set an important precedent related to emergency response related to ammonia releases.



#### **CANADIAN ADVOCACY**

Through its new advocacy partnership, GCCA has greatly increased its visibility and impact with the Canadian government. In 2022, GCCA participated in consultations on key policy issues including: supply chains, regulations, labour, agricultural policy framework, transport, cyber security, and the budget. GCCA has held meetings with high-ranking officials from key government agencies including CFIA, Agriculture and Agri-Food Canada, Transport Canada and the National Supply Chain Task Force.

### **BUILT BY THE BEST AWARD OVER \$35 MILLION - GRIFFCO DESIGN/BUILD**

For its winning entry, Griffco Design/Build was selected to complete Phase 1 of Americold Logistics' Gateway project in Atlanta, Georgia. It encompassed the demolition of a 440,000-squarefoot existing cold storage building and the construction of a new, 200,000-square foot automated freezer facility. Parameters for the new Gateway facility included a 150-foot, -10-degree ASRS, -10 degree low-bay freezer; 35-degree truck and rail dock; and a twostory office building. The ASRS included 41,000 pallet positions, while the low-bay freezer included 6,000, totaling 47,000 pallet positions.

## **UNDER \$35 MILLION CEBA BUILT BY THE BEST AWARD RECIPIENT - COLDBOX**

When Confederation Freezers saw business boom, it acted quickly to hire Coldbox to expand and alter its current facility by 109,000 square feet in an effort to meet the rising demand of customers. Coldbox's progressive design-build approach with Confederation Freezers was a partnership rather than a competitive bid scenario, which allowed the company to focus on the business's future growth needs collectively. The design process for the project started in January 2019, demolition commenced March 2019, construction began July 2019 and the facility was substantially performing by January 2021. Comprised of two cold rooms, the project included one space operating as a freezer/cooler swing space, where the temperature could be set anywhere from 39°F to -13°F, depending on demand. This room was adjacent to a freezer continuously operating at 0°F.

#### THE CERTIFIED COLD CARRIER

The global Certified Cold Carrier program managed by the Global Cold Chain Alliance provides independent, third-party assurance that asset-based refrigerated carrier companies are aligned with industry-prescribed best practices for the safe and sanitary transport of food perishables. These best practices are published in GCCA's Refrigerated Transportation Best Practices Guide and are based on the Sanitary Transportation of Human and Animal Food (STF) rule of the U.S. Food Safety Modernization Act (FSMA). For 2022, United States Cold Storage fulfilled the requirements to be awarded Certified Cold Carrier. The Program now has thirteen certified carriers: Charger Logistics Inc, Congebec Logistics, Daytona Freight Systems, FFE Transportation Services, FLGO Freight, JB Hunt, Midwest Refrigerated Services, Inc., Penske Logistics, Prime, Inc., Sethmar Transportation Inc., Trailiner, United States Cold Storage.







## THE GCCA ENERGY EXCELLENCE RECOGNITION PROGRAM (EERP)

Warehouse energy usage is the second highest cost in the cold storage industry behind labor. Managing energy usage costs is a high priority for temperature-controlled facilities. The Global Cold Chain Alliance's Energy Excellence Recognition Program (EERP) provides measures to improve energy efficiency at temperaturecontrolled facilities. EERP also communicates each facility's progress in meeting sustainability objectives to customers, highlighting partnerships with cold chain sustainability. The program now has over 200 recognized refrigerated warehouses. Companies participating in EERP are Americold Logistics, Congebec Logistics, MW Cold, and MTC Logistics.








