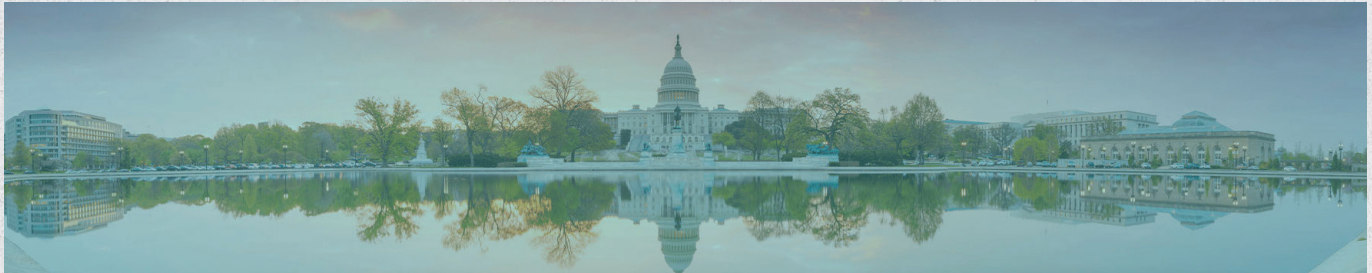

## GCCA STANDS WITH YOU. THE TIME TO ACT IS NOW.

The cold chain industry continues to face uncertainty and vulnerability from America's policy makers in the White House and in both chambers of Congress. It is important that the industry come together to address these challenges and opportunities.

The Administration and Congress are considering a wide range of policies that could impact the cold chain in 2024. 2024 is an election year with contested battles for control of the House, Senate, and White House, and ensuring your voice is heard is critically important.

Below are priority areas GCCA will be focusing on in 2024:



### FARM BILL

- Congress is working to reauthorize the Farm Bill in 2023
- GCCA successfully secured the introduction of the FRIDGE Act in 2023
- GCCA will be actively engaging with Congress to advance the FRIDGE Act as the Farm Bill process moves forward



### LABOR

- Addressing labor policies such as worker organizing, collective bargaining, and legislation such as the PRO Act
- Tracking NLRB activities, including 'micro-unit' organizations and joint employer policies



### CLIMATE CHANGE

- Engaging with policy makers on sustainability and climate change legislation and regulations.
- Continued implementation of the AIM Act to phase down HFCs



### BURDENSOME REGULATIONS

- Revising EPA's Risk Management Program (RMP) regulation and making additional requirements
- Changes to OSHA's Process Safety Management regulation
- Implementation of FDA's Food Traceability Rule
